NOTICE OF ANNUAL GENERAL MEETING

This document is the formal notification to shareholders of the Annual General Meeting of Sopheon plc (the “Company”), its date, time and place and the matters to be considered (numbered 1 to 8 below). It is an important document. If you are in any doubt about the contents of this document or about what action you should take, you should consult your stockbroker, accountant or other independent professional advisor authorised under the Financial Services and Markets Act 2000 (as amended). Separate notes on the proxy form attached explain the arrangements for shareholders to exercise their voting rights. If you have sold or transferred all of your Sopheon plc ordinary shares, please pass these documents to either the purchaser or transferee or the person through whom the sale or transfer was effected for onward transmission to the purchaser or transferee. As further described on the back page of this notice, we now distribute certain Shareholder Documents through the Company’s website. Pursuant to the above, we hereby notify you that the Annual Report for the year ended 31 December 2019 is available on our website at www.sopheon.com. Unless you have previously elected to do so, to receive a hard copy of the Annual Report free of charge, please write to the Company’s registered office.

NOTICE is hereby given that the Annual General Meeting of the Company for 2020 will be held at the Company’s registered office at Dorna House One, Guildford Road, West End, Surrey GU24 9PW on 11 June 2020 at 11:00am for the purposes set out below. **Due to the current government restrictions regarding travel, public gatherings and social distancing, shareholders are not expected to attend the meeting in person and are encouraged to submit a proxy vote by email in accordance with the instructions later in this document. Appointing a proxy will enable your vote to be counted in your absence. Arrangements have been made to ensure a quorum at the meeting, and other shareholders attempting to attend in person will be refused entry.**

ORDINARY BUSINESS (all Ordinary Resolutions)

1. To receive and to adopt the report of the Directors and the auditors and the Company's accounts for the year ended 31 December 2019.
2. To declare a final dividend for the financial year ended 31 December 2019 of 3.25 pence per ordinary share in the capital of the Company payable to holders of ordinary shares whose names appear on the register of members at the close of business on 12 June 2019.
3. To re-appoint Stuart Silcock as a Director of the Company, who is retiring by rotation as required by the Company’s Articles.
4. To re-appoint Arif Karimjee as a Director of the Company, who is retiring by rotation as required by the Company’s Articles.
5. To re-appoint BDO LLP as auditors to hold office from the conclusion of the meeting to the conclusion of the next meeting at which the accounts are laid before the Company and to authorise the Directors to determine their remuneration.

SPECIAL BUSINESS

Resolutions 6 and 8 are proposed in order to provide respectively for (i) Directors’ general authority to allot shares and other equity securities and (ii) authority to be given to the Directors to issue shares for cash. Resolution 7 is proposed in order to provide for the Company to purchase its own shares.

As was the case for resolutions passed at the Company’s 2019 Annual General Meeting, the authorities referred to in resolutions 6, 7 and 8 will not expire until after five years, but in accordance with good practice, the Directors intend to update and renew such authorities on an annual basis at subsequent Annual General Meetings.

To consider and, if thought fit, pass the following resolutions as Ordinary Resolutions:

6. That the Directors be and are hereby generally and unconditionally authorised, pursuant to and in accordance with Section 551 of the Companies Act 2006 (the “Act”), to exercise all the powers of the Company to allot equity securities (within the meaning of that Section) up to a maximum aggregate nominal amount of £664,522, but so that such authority (unless previously renewed, revoked or varied) is to expire on 10 June 2025, but so that the Company may, before such expiry, make an offer or agreement which would or might require relevant securities to be allotted after such expiry and the Directors may allot relevant securities pursuant to any such offer or agreement as if such authority had not expired. This authority is in substitution for all previous authorities conferred upon the Directors pursuant to Section 551 of the Act, but without prejudice to the allotment of any relevant securities already made or to be made pursuant to such authorities.

To consider and, if thought fit, pass the following resolutions as Special Resolutions:

7. That the Company be and is hereby generally and unconditionally authorised in accordance with section 701 of the Act to make market purchases (within the meaning of Section 693(4) of the Act) of ordinary shares in the capital of the Company on such terms and in such manner as the Directors shall from time to time determine, provided that:
- (a) the maximum number of ordinary shares hereby authorised to be acquired shall be 1,000,000;
 - (b) the minimum price, exclusive of any expenses, which may be paid for any ordinary share will be its nominal value; and
 - (c) the maximum price, exclusive of any expenses, which may be paid for any ordinary share shall be the higher of (i) an amount equal to 105 per cent. of the average middle market quotations for the ordinary shares (derived from the AIM appendix to the London Stock Exchange's Daily Official List) for the five business days prior to the date of purchase; and (ii) an amount equal to the higher of the price quoted for the last independent trade of an ordinary share and the highest current independent bid for an ordinary share on the trading venue where the purchase is carried out, provided that such authority (unless previously renewed, revoked or varied) is to expire on 10 June 2025, but so that that the Company may make a purchase of ordinary shares under such authority after the expiry of this authority, if the contract of purchase for the same was concluded before such date and will or may be executed wholly or partly after such expiry.
8. That the Directors be and are hereby empowered pursuant to Section 570 of the Act to allot equity securities (as defined in Section 560 of the Act) for cash pursuant to the authority conferred by resolution 7 above, as if Section 561 (1) of the Act did not apply to any such allotment provided that such power is limited to:
- (a) the allotment of equity securities in connection with an issue or offering by way of open offer or rights issue to holders of equity securities in proportion (as nearly as may be practicable) to the respective numbers of equity securities held by or deemed to be held by them on the record date of such allotment, but subject to such exclusions or other arrangements as the Directors may deem necessary or expedient to deal with any fractional entitlements or any legal or practical problems under the laws of any overseas territory or the requirements of any regulatory authority or any stock exchange;
 - (b) the allotment (otherwise than pursuant to paragraph (a) above) of equity securities up to a maximum aggregate nominal amount of £200,000;

provided that the power hereby conferred shall operate in substitution for and to the exclusion of any previous power given to the directors pursuant to Section 570 of the Act and that such authority is to expire on 10 June 2025, save that the Company may before such expiry make offers or agreements which would or might require equity securities to be allotted after such expiry and the Directors may allot equity securities pursuant to any such offer or agreement as if such authority had not expired.

Notes to Notice of Annual General Meeting:

1. A member is entitled to appoint another person as his proxy to exercise all or any of his rights to attend, speak and vote at the meeting. A member may appoint more than one proxy in relation to the meeting, provided that each proxy is appointed to exercise the rights attached to a different share or shares held by him. A proxy need not be a member of the Company but must attend the meeting to represent you. Details of how to appoint the Chairman of the meeting or another person as your proxy using the proxy form are set out in the notes thereto.
2. Pursuant to Regulation 41 of the Uncertificated Securities Regulations 2001, to be entitled to attend and vote at the meeting (and for the purposes of the determination by the Company of the number of votes they may cast) members must be entered on the Company's register of members by close of business on 9 June 2020.
3. A form of proxy is enclosed. To be effective, it must be deposited at the Company's registered office so as to be received not later than 48 hours before the time appointed for holding the meeting.
4. Copies of the following documents will be available for inspection at the Company's registered office during normal business hours on any weekday from the date of this notice until the AGM and at the AGM for a period of 15 minutes before the commencement until the conclusion of the AGM:
 - (a) the executive directors' service agreements and non-executive directors' letters of appointment with the Company;
 - (b) register of interests of the directors and their families in the share capital of the Company; and
 - (c) Memorandum and Articles of Association.

Given the Coronavirus situation, notwithstanding the notes above, Shareholders and their proxies will not be able to attend the meeting in person nor will they be allowed access to the Company's offices for inspection of documents at this current time. Accordingly, Shareholders are urged to appoint the Chair of the meeting as proxy and if you are a Registered Shareholder, to send a scan of your completed and signed proxy form by email to agm20@sopheon.com.
